## **ATTENTION**: The "health PASS" is mandatory for these days

What is the "health pass " (pass sanitaire)? (see <a href="https://www.gouvernement.fr/info-coronavirus/pass-sanitaire">https://www.gouvernement.fr/info-coronavirus/pass-sanitaire</a>)

The "health pass" consists of the presentation, digitally (via the TousAntiCovid application) or on paper, of one of the following three health proofs

- 1. Vaccination, provided that people have a complete vaccination schedule and the necessary time after the final injection
- 2. Proof of a negative test less than 72 hours old (or 48 hours for antigenic tests for travel to certain destinations, such as Corsica, the overseas territories and the European Union)
- 3. The result of a positive RT-PCR or antigenic test attesting to the recovery of Covid-19, at least 11 days old and less than 6 months old.

For which locations is the "health pass" mandatory? ( see <a href="https://www.gouvernement.fr/info-coronavirus?xtor=SEC-3-GOO-[]-[511792643929]-S-[corona%20virus])</a>

- The "health pass" is compulsory in all departments for access to certain places, establishments or events, indoors or outdoors, without any notion of capacity, such as cinemas, museums, cafés, restaurants, hospitals, retirement homes, medical and social establishments (except in emergencies);
- Long-distance travel by inter-regional public transport is also affected;
- Since 8 September, the "health pass" is no longer compulsory in shopping centers in departments where the incidence rate is less than 200/100,000 and has been continuously decreasing for at least 7 days.
- Since 30 September 2021, the "health pass" is compulsory for minors aged between 12 years and two months and 17 years.

Travellers aged 12 years or over from a country in the European area are required to present

- either proof of having received all the doses prescribed for one of the vaccines approved by the European Medicines Agency (complete vaccination schedule, more than 7 days old (AstraZeneca, Pfizer or Moderna) or more than 28 days old (Janssen, single-dose vaccine).
- or for non-vaccinated persons, a PCR or antigenic test (TAG, for the latter: detection of the sars-cov 2 N protein) is required on departure from Spain to France. This test must be less than 24 hours old.
- or a Covid-19 recovery certificate, valid for 180 days after the first positive diagnostic test. This document must mention the date of the first positive test, the type of test carried out and the country where the certificate was issued.
- or the health pass, recognised for travel within the European area, in the form of a European certificate
